POSITION TITLE: Clinical Service Provider I, Salt Fork Adventure Program, Position 10-S026

THE POSITION: Under general supervision, provides clinical services to residents and families in a community residential program for delinquent male youth who are in custody of the Office of Juvenile Affairs; works closely with OJA personnel to schedule, coordinate, and efficiently integrate new admissions into the program; performs intakes and ensures intake packets are completed; develops, implements, and administers services and treatment plans; conducts individual, group, and family therapy, with a focus on youth's personal goals; participates in a team effort with other units while acting in a leadership role in communicating the plans of service and counseling strategies to meet the residents' individual needs; consults with individual and community organizations on the improvement of children services; acts as a liaison to SWOSU in facilitating practicum student opportunities.

QUALIFICATIONS: Completion of the requirements for a Masters Degree in Social Work, Psychology, or related field; successful work experience in dealing with children or adolescents in a similar setting; strong organizational, time management, crisis, behavioral management, and intervention skills and abilities; ability to handle multiple assignments simultaneously and properly handle stressful situations; and emotional maturity required. Must be under board supervision for licensure in one of the following areas: Licensed Professional Counselor (LPC), Licensed Clinical Social Worker (LCSW), Licensed Behavioral Practitioner (LBP), Licensed Alcohol and Drug Counselor (LADC), or Licensed Marriage & Family Therapist (LMFT). Must be willing to be subject to 24 hour on call duty as related to clinical issues; maintain a current and valid Oklahoma Drivers License; and be able to pass drug test and criminal background check; have knowledge of the methods and theories used in a therapeutic residential setting inclusive of skills in groups and individual therapy, the juvenile justice system, and current issue affecting treatment related to juvenile delinquency, adolescent development and family dynamics.

SALARY: Commensurate with existing salary structure.
