Request for Form I-20 Extension

Eligibility Criteria for I-20 Extension

- Extensions can be granted only for **documented academic or medical reasons**.
- Students requesting an I-20 extension must prove they have **sufficient financial resources to fund their studies and living expenses**.
- Applications for I-20 extensions must be **filed in a timely manner** (Please apply at least 1-2 months prior to the expiration of your current Form I-20). Once the program end date has already passed, Form I-20 can no longer be extended!

The following are NOT valid reasons for I-20 extensions:

- Repeating courses to improve your GPA
- Enrolling in extra courses not required for the completion of the degree program.
- Participating in non-required internships / training or engaging in non-required research
- Delays caused by academic probation or suspension.

“(iii) Program extension for students in lawful status. An F-1 student who is unable to meet the program completion date on the Form I-20 may be granted an extension by the DSO if the DSO certifies that the student has continually maintained status and that the delays are caused by compelling academic or medical reasons, such as changes of major or research topics, unexpected research problems, or documented illnesses. Delays caused by academic probation or suspension are not acceptable reasons for program extensions. A DSO may not grant an extension if the student did not apply for an extension until after the program end date noted on the Form I-20. An F-1 student who is unable to complete the educational program within the time listed on Form I-20 and who is ineligible for program extension pursuant to this paragraph (f)(7) is considered out of status. If eligible, the student may apply for reinstatement under the provisions of paragraph (f)(16) of this section.”[8 CFR 214.2 (f) (7) (iii)]

Documentation

Documents listed below must be completed and submitted to a Designated School Official at the International Student Services, or by email to international@swosu.edu

- “Request for Form I-20 Extension” completed and signed by the student and his/her Academic Advisor
- Undergraduate / Graduate Certificate of Financial Resources and a recent bank statement in the sponsor’s name, or other accepted supporting financial documents
- Updated copy of the photo page in your passport & copy of your most recent Form I-94
- Copy of your most recent I-20 showing you have been maintaining F1 status
- An unofficial transcript (a degree check is highly recommended)
- Proof of medical conditions if the delay s caused by medical reasons.
